

20kBTC Terms Agreement

This Agreement sets forth the legal terms and conditions of your use of the 20kBTC website and various related sites and services. Your use of this website is subject to your compliance with all the terms, conditions, and notices contained or referenced in this Agreement, as well as any other written agreement between us.

1. Acceptance of Terms.

20kBTC ("20kBTC" or "we", "us", "our") provides access to the 20kBTC website, located at www.20kBTC.com, (the "website") subject to your acceptance of this website User Agreement ("Agreement").
